Therapies United Registration Guidelines

Thanks for expressing an interest in the Therapies United Register. As you know there is a registration process to follow to determine if you will be accepted on to the register.

Enclosed is a registration form which you must complete and return with:

- copies of certificates pertaining to the therapies you practice and wish to be listed on your entry
- a copy of insurance cover that you have as a therapist practitioner - this must detail the therapies you are insured to practice
- signed Terms and Conditions
- your registration fee payment
- a completed standing order (if appropriate)

Please note that if you don't have insurance cover, your registration won't be accepted. Email us on info@therapiesunited.com and we can provide you with insurer details.

Your registration payment is required to process your forms. You must complete the 'options' at the end of your registration form to confirm which sections of Therapies United you wish to join.

Also enclosed is a standing order form which you must complete and return with your registration fee for the optional opportunity to be contacted about paid therapy taster/workshop session opportunities. You must be listed on the main register before you can be considered for this separate section. The cheque for your registration fee should be payable to 'Feel Good Therapies - Ref Therapies United'. Please note, that no payment will be taken unless your registration is accepted.

If we need to contact you about your registration form, please ensure that you have stated a daytime phone number on your registration form.

Hopefully, your registration will be successful and we'll then contact you to confirm your entry. The next step will involve setting up your profile in the register for the website and manual version in the Maggie's centre and other Partner Organisation listings. As per the terms and conditions, the people who come to you via Maggie's centre and our other partnership organisations will be entitled to a 10% discount of your normal rates.

You can always provide this at a later date as your entry will show indicate this.

Costs explained

The registration fee of *£59 covers the admin costs of setting this up within one centre's manual register. The 2nd centre fee (optional) covers the cost of placing your details within the manual centre.

- The optional £7.50/month charge covers your listing in the separate register to be informed of workshop/therapy taster session work. (25% discount if paid annually)

Next Steps

If successful you will receive an email from us congratulating you on being accepted on to the register. We'll ask you to complete an email so we can set up your profile. This takes approximately 7 - 10 days. We will then place your details in the register both online and in the manual registers.
